APPENDIX 3: INVENTORY OF OPEN SPACES AND OTHER ENVIRONMENTALLY SIGNIFICANT SITES

1. Rationale

This environmental inventory of Ashby de la Zouch was compiled in support of the environmental designations in this Plan, and the policies to be applied to them, between March and July 2023. The work comprised two elements:

- Review of all existing designations and other available information in the public domain and
- Fieldwork to identify and confirm environmentally significant (in the context of the Plan Area) sites and features.

The <u>review</u> compiled information from many sources, including DEFRA, Natural England, Historic England, Leicestershire Historic Environment Records, Leicestershire Environmental Record Centre (habitats, species and designations), North West Leicestershire Council, Environment Agency, British Geological Survey, old maps (Ordnance Survey, archive), local history and archaeology, publications and local knowledge. The <u>fieldwork</u> was combined with local desk studies to review all open and currently undeveloped land in the Plan Area. Significant species, habitats, public open spaces, landscape characteristics, earthworks and other extant heritage features, views and viewpoints were checked and recorded.

These data, along with all relevant site-specific information from the existing information review, were mapped and tabulated, and every site of local environmental significance was evaluated using a system (see below) based on the seven criteria for Local Green Space selection in the *National Planning Policy Framework* 2023



	huge area of open space and a large number of beautiful mature trees all of which have been catalogued and are regularly inspected. The site also accommodates the Ashby Hastings Cricket Club (pitch) and Ashby Bowls Club (enclosed green and clubhouse) A heritage trail has been laid out around the grounds by the Friends of Ashby Bath Grounds with notice boards and market posts, explaining the historical and modern contexts. According to one of these notice boards, "Ashby's historic Bath Grounds have been enjoyed by residents and visitors to Ashby for 200 years. Known previously as Hall Meadow, they were laid out formally as an area of fashionable greensward' for the benefit of visitors to the new Ivanhoe Baths, built in 1822, at the western end of the park. They included a carriage drive and footpaths used for 'sedate and genteel recreation'. "By 1827 the Royal Hotel, Rawdon House and Terrace and Ivanhoe Terrace had been completed nearby, to provide boarding accommodation for visitors to Ashby Spa. These, and the later Midland Railway Station, are all Grade 2* listed and accredited to the architect surveyor Robert Chaplin. Chaplin worked in Ashby between 1831 and 1850. To the east, the Bath Grounds are bounded by the former course of the now culverted Gilwiskow Brook which provided fresh water to the ancient settlement of Ashby, the castle, and its fishponds. The Bath Grounds remain a source of inspiration to this day. They provide a beautiful venue for community events and sporting endeavour, a tranquil oasis for reflection and a pleasant meeting place for dog walkers. They form a key component of the "Green Corridor" to Ashby Castle. The Grounds are still owned by the proprietors of the Royal Hotel, but have been maintained and operated as a public park for over 50 years by Ashby de la Zouch Town Council. Kenneth Hillier in the latest, 2016 edition of his book, 'The Ivanhoe Baths and the Bath Grounds' says, "They really are the countryside in the Town".
