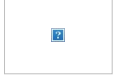
Breedon on the Hill Neighbourhood Plan

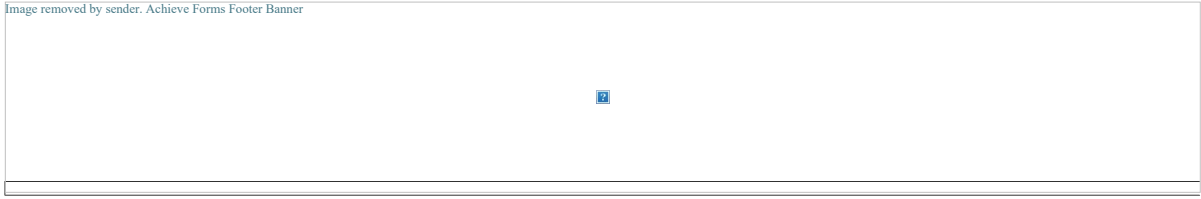
