Please see below a summary of North West Leicestershire District Council activity in Castle Donington from 1st April 2010 to 31st March 2014

Economic Development

Love Business - East Midlands

The launch of the pilot Love Business East Midlands networking event took place at Donington Park in February 2012, attracting business from the district and further afield, providing a networking platform.

Working with Marks and Spencer

In February 2013 we worked in partnership with M&S on a recruitment support session, helping to recruit local workers for the vacancies with M&S at their distribution centre in Castle Donington.

New business enquiries

As at December 2013 assistance had been give to 5 businesses in Castle Donington with advice about relocation, growth, networking opportunities etc. A further 3 businesses have been assisted with advice about moving to or starting up in Castle Donington.

Formula E

NWLDC supported Donington Park to attract Formula E to the area by enabling planning approvals to progress efficiently and speedily. Formula E will be based at a £5.7 million building at Donington, funded by a £3.65 million loan from the Government's Growing Places Fund and a £2.05 million investment from circuit owner Kevin Wheatcroft.

Destination Donington

NWLDC has supported the inception of Destination Donington. Destination Donington is a partnership between Donington Park Exhibition and Conference Centre, high quality accommodation, North West Leicestershire District Council and Leicester Shire Promotions that provides one unique location for large conferences and exhibitions. Destination Donington is managed by Leicester Shire Promotions Ltd.


Unemployment

Vacancy rates

Vacancy rates for Castle Donington centre are collected on a quarterly basis. The vacancy rate in January 2014 was 1.8% which is down from a high of 7.1% in May 2012.

Vacancy rates for Castle Donington industrial estates are collected on an annual basis. In 2013 there were 263 units with 38 voids – 14.4%

In 2014 there were 265 units with 31 voids -11.7% (The number of units increased because of subdivision rather than development.)
