

# **BROOM LEYS- HUGGLESCOTE- WHITWICK CEMETERY**

## **FEES AND CHARGES WITH EFFECT FROM 1 APRIL 2025**

A sliding scale for Interments and Exclusive Rights of burial is shown below.

### **SINGLE FEES**

Anyone living in the former Coalville Urban District Council at time of death.

**For residents living in care homes outside the area for less than twelve months prior to date of death, the Funeral Director / applicant must provide evidence to qualify for single fees e.g., Council Tax bill.**

Anyone living in Ellistown who pre-purchased a grave in any of the above cemeteries prior to 2002 when Ellistown became a Parish, and resided in Ellistown at the time of death will be charged single interment fees.

### **DOUBLE FEES**

Evidence of residency in the former Coalville Urban District Council between 1 and 5 years to date of death, needs to be provided by the Funeral Director / applicant.

### **TREBLE FEES**

Evidence of residency in the former Coalville Urban District Council must be provided by the Funeral Director / applicant if more than 5 years.

### **\*THE CHILDRENS TRUST FUND**

Effective from the 23rd of July 2019, the government introduced the Children's Funeral Fund (CFF). Where applicable, fees associated with the funeral of a child up to and including the age of 17 will be claimed from the Children's Funeral Fund. This will also include the first application fee for a memorial stone on a child's grave/plot.

#### **Please Note**

**\*The Children's Funeral Fund** requires that all claims must be submitted within 6 months of the funeral date. For all requests following a funeral, i.e., for ashes interments, scatterings, headstones, etc. please be aware these **MUST** be received by North West Leicestershire District Council in time to allow processing and for a claim to be made prior to this deadline,
