The hearings, appeals and registrations took over twenty years but the Parish was finally granted ownership of the village green and the round house and penfold. | | | |

| | <p>Historically, many households had grazing rights over The Green. The Green remained picturesque until the 1930s, after which it was neglected and deteriorated. During the 1930s domestic rubbish was dumped in the Fishpools (the area to the west) and by the 1940s the Green was an eyesore- a tangled mess of weeds and brambles.</p> <p>In 1955, the managing director of the quarry decided to do something about it. In 1956, the quarry company carted soil to The Green to fill the boggy land. The stream was diverted and culverted. The Green became a smooth expanse of well-kept grass and neat little fences.</p> <p>This began a complete transformation of the village and in 1978 Breedon was awarded Best Kept Village in a competition run by the Leicester Advertiser.</p> |

| | <p>The war memorial on The Green commemorates the fallen from the First and Second World Wars.</p> |
