# FOOTPATH 0111 LAND BETWEEN THE ROYAL HOTEL STATION ROAD AND ASHBY BATHGROUNDS ASHBY DE LA ZOUCH PUBLIC PATH DIVERSION ORDER 2021

This Order is made by North West Leicestershire District Council under Section 257 of the Town & Country Planning Act 1990, because it is satisfied that-

it is necessary to divert the footpath to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part 3 of the Town and Country Planning Act 1990, namely: the erection of 17 townhouses with associated car parking access, landscaping and car park to hotel and associated access amendments at The Royal Hotel, Station Road, Ashby de la Zouch, Leicestershire, planning application reference 22/01552/FULM.

#### BY THIS ORDER

- The footpaths over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order shall be diverted as provided below.
- 2. There shall be created to the reasonable satisfaction of the North West Leicestershire District Council an alternative highway for use as a replacement for the said footpaths, as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
- 3. The diversion of the footpath shall have effect on the date on which North West Leicestershire District Council certify that the terms of Article 2 above have been complied with.
- 4. The following works shall be carried out in relation to the highway described in Part 2 of the Schedule.
  - (a) Alternative Footpath O111 shall have a minimum clear width of 2.0 metres.
  - (b) Fingerpost to be installed where the alternative route for the Public Footpath meets the vehicular Highway. The Fingerpost is to be provided and installed by Leicestershire County Council, funded by the developer.
  - (c) Waymark posts to a specification shown in Standard Design Drawing SDFP6 to be installed at locations agreed with Leicestershire County Council along the alternative route of the Public Footpath

- (d) Surfacing, to a specification agreed by Leicestershire County Council, to be constructed along the alternative route of Public Footpath O111
- 5. The Developer is hereby required to pay the cost of carrying out the said works.
- 6. This Order may be cited as the District of North West Leicestershire Footpath O111 Land between the Royal Hotel Station Road and Ashby Bath Grounds, Ashby-de-la-Zouch Public Path Diversion Order 2021.

#### **SCHEDULE**

#### PART 1

### **DESCRIPTION OF SITE OF EXISTING PATH OR WAY**

That part of public footpath O111 within the ward of Ashby Willesley and the District of North West Leicestershire as shown by a bold black line on the plan annexed hereto which extends from the point marked A on the plan, situated at grid reference SK 35594 16307 in a generally East North-Easterly and North North-Easterly directions for a distance of approx. 93 metres to point C on the plan at Grid Reference SK 35648 16327

The footpath to be diverted has a width of between 2 and 3 metres.

# **DESCRIPTION OF SITE OF ALTERNATIVE HIGHWAY**

A footpath within the ward of Ashby Willesley and the District of North West Leicestershire to be known as O111, as shown by broken black dashes on the plan annexed hereto, which will extend from the point marked t B on the plan, situated at Grid Reference SK 35590 16345 in a generally East North-Easterly and Easterly directions for a distance of approx. 83 metres to point C on the plan at Grid Reference SK 35648 16327


The alternative footpath will have a width of 2.0 metres


